## Singapore Management University

The INTA Foundation and Singapore Management University have joined forces to introduce a new award called the "INTA Foundation Social Innovation Prize" for the Lee Kuan Yew Global Business Plan Competition (LKYGBPC). This award was given to two innovation startup teams who have used brands and IP to address pain points in society.

The following are details about the winning inventions:

- Based in China - The Zhiyin AI Intelligent System is an innovative solution designed to foster communication between hearing-impaired individuals and those with normal hearing. This cutting-edge system employs speech recognition, speech synthesis, gesture recognition, and augmented reality technologies to bridge the communication gap, facilitating seamless interaction and understanding between these two groups.
- Based in Indonesia – The Raga Arm is an arm prosthesis that combines functionality with user-friendliness and has a bionic-inspired design. This innovative device enhances capabilities and usability for its users, empowering individuals with diverse abilities to embrace active lifestyles through accessible assistive technology.

## Universidade Federal do Rio de Janeiro

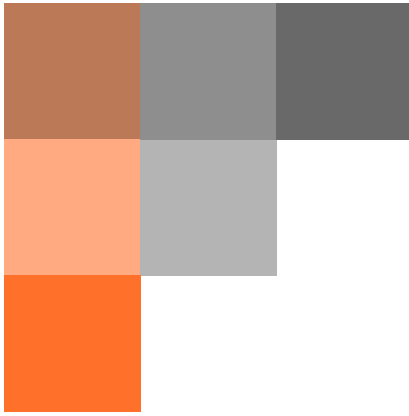
Thanks to the INTA Foundation Fellowship grant, the Universidade Federal do Rio de Janeiro (UFRJ) Law School has launched an unprecedented program. The program offers a comprehensive IP curriculum encompassing patents, trademarks, copyright, and specialized English language courses to a group of fifteen students. This program includes a 15-hour internship with local law firms. Notably, it places a strong emphasis on diversity equity, and inclusion, with reserved spots for under-represented communities, including low-income, Black, indigenous, and disabled students. This inaugural grant offers a distinctive opportunity for aspiring IP professionals to excel in their field.
